AMENDED INFRACTION PROCEDURES

You have received a citation alleging that you have committed an infraction of the law. You have a right to be advised of the statute involved and to have a reasonable continuance to employ an attorney. If you deny the infraction the matter will be set for a trial. The burden would be upon the State to prove by a preponderance of the evidence that you committed the infraction by evidence presented in open court. You have the right to see, hear, and cross examine all witnesses against you. You have a right to present witness testimony and other evidence on your behalf, and the court would assist you in that right by issuing subpoenas. If the court found against you after a trial you could appeal that decision according to the Indiana Rules of Appellate Procedure. If you admit the infraction you would be giving up all of the rights described above.

If you wish to admit that you committed the infraction, you may do so by sending a money order in an amount of \$1.00 for each citation you have been charged with plus \$133.50 for court costs. (For example, if you wish to admit three (3) charges you would send \$3.00+\$133.50=\$136.50) Send only \$25.00 for Seatbelt or Child Restraint Violation with no court costs. THE COURT WILL ALLOW CITATIONS FOR SPEEDING OVER 25 MILE PER HOUR AND SPEED TOO FAST FOR ROAD CONDITIONS OR TO AVOID COLLISION TO BE PAID WITH A FINE OF \$35.00 PLUS \$133.50 COURT COSTS FOR A TOTAL OF \$16850. Make your payment within thirty (30) days of the date of the citation or contact the Clerk of the Carroll Superior Court (765-564-4485) for further payment options. PERSONAL CHECKS ARE NOT ACCEPTED. Please include a signed copy of the citation with your payment. Payment should be made payable to the Clerk of the Carroll Superior Court, 101 W Main St, Ste 206, Delphi, IN 46923. For driving offenses, a record of the judgment in this matter will be sent to the Bureau of Motor Vehicles and become a part of your permanent driving record. The Bureau of Motor Vehicles may take additional action as provided by law.

If you wish to deny the infraction, contact the court at 765-564-2136 to schedule a trial date.

You must appear in court on the date listed on your citation if you have been cited for the following:

- *Driving While Suspended
- *Improper passing of school bus
- *Construction Zone-Speeding
- *Trucks-Over weight violations
